

# DSWD DROMIC Report on the Fire Incident in Brgy. Lapaz, Jamindan, Capiz

19 March 2025, 6PM

#### I. Situation Overview

On 3 March 2025, at around 10:00 AM, a residential fire broke out in Barangay Lapaz, Jamindan, Capiz. The Bureau of Fire Protection promptly responded to the fire call, and the blaze was extinguished by around 11:00 AM.

The affected family temporarily sought shelter with relatives while making arrangements to rebuild their damaged home.

In response to the incident, the Department of Social Welfare and Development (DSWD), through its Field Office in Region VI, extended relief assistance, to meet the immediate needs of the displaced family.

One (1) family or four (4) persons were affected in Brgy. Lapaz, Jamindan, Capiz (see Annex A).

## III. Status of Displaced Population

#### **Outside Evacuation Center**

One (1) **family** or **four (4) persons** temporarily stayed with their relatives (see Annex B).

## IV. Damaged Houses

One (1) house was totally damaged in Brgy. Lapaz, Jamindan, Capiz (see Annex C).

#### V. Cost of Humanitarian Assistance Provided

A total of **₱6,298.00** worth of assistance was provided by **DSWD** to the affected family (see Annex D).
