I. Situation Overview

On 04 March 2025 at around 2:30 AM, a fire incident occurred in Brgy. Maliao, Tapaz, CapiZ. The fire was declared out at around 3:00 AM.

One (1) family or **five (5) persons** were affected in **Brgy. Maliao, Tapaz, CapiZ** (see Annex A).

Outside Evacuation Center

One (1) family or **five (5) persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One house was **totally damaged** in **Brgy. Maliao, Tapaz, CapiZ** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱14,272.00** worth of assistance was provided to the affected family; of which, **₱4,272.00** from **DSWD** and **₱10,000.00** from the **Local Government Unit (LGU)** (see Annex D).
