### **I. Situation Overview**

On 09 March 2025 at around 11:56 PM, a fire incident occurred in Brgy. Mansilingan, Bacolod City.

**One (1) family or four (4) persons** temporarily stayed with their relatives (see Annex B).

### **IV. Damaged Houses**

**One (1) house** was **totally damaged** in **Brgy. Mansilingan, Bacolod City** (see Annex C).

### **V. Cost of Humanitarian Assistance Provided**

A total of **₱10,790.00** worth of assistance was provided to the affected family; of which, **₱6,500.00** from **DSWD** and **₱4,290.00** from the **Local Government Unit (LGU)** (see Annex D).
