I. Situation Overview

On 26 February 2025 at around 12:30 PM, a fire incident occurred in Brgy. Navillan, Tubungan, Iloilo. The fire was declared out at around 2:00 PM.

One (1) house was **totally damaged** in **Brgy. Navillan, Tubungan, Iloilo** (see Annex C).
