### I. Situation Overview

On 05 February 2025 at around 7:00 PM, a fire incident occurred in Brgy. Nibaliw, Mangaldan, Pangasinan.

A total of **₱30,905.01** worth of assistance was provided to the affected person; of which, **₱20,905.01** from **DSWD** and **₱10,000.00** from the **Local Government Unit (LGU)** (see Annex D).
