## I. Situation Overview

On 09 March 2025 at around 8:00 AM, a fire incident occurred in Brgy.Poblacion 4, City of Tanauan, Batangas. The fire was declared out at around 1:12 PM.

**One (1) family** or **five (5) persons** temporarily stayed with their relatives (see Annex B).

### IV. Damaged Houses

**One (1) house** was **totally damaged** in **Brgy. Poblacion 4, City of Tanauan, Batangas** (see Annex C).

## V. Cost of Humanitarian Assistance Provided

A total of ₱6,879.35 worth of assistance was provided to the affected families; of which, ₱1,879.35 from DSWD and ₱5,000.00 from the Local Government Unit (LGU) (see Annex D).
