I. Situation Overview

On 18 February 2025 at around 6:59 PM, a fire incident occurred at Las Brisas, Brgy. Poblacion, Sual, Pangasinan.

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Poblacion, Sual, Pangasinan** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱30,959.35** worth of assistance was provided to the affected family; of which, **₱20,959.35** from **DSWD** and **₱10,000.00** from the **Local Government Unit (LGU)** (see Annex D).
