

DSWD DROMIC Report on the Fire Incident in Brgy. San Isidro, Las Nieves, Agusan del Norte

13 March 2025, 6AM

I. Situation Overview

On 21 February 2025 at around 4:00 AM, a fire incident occurred at Purok 2, Brgy. San Isidro, Las Nieves, Agusan del Norte. The fire was declared out at around 5:00 AM.

II. Status of Affected Areas and Population

One (1) family or **four (4) persons** were affected in **Brgy. San Isidro, Las Nieves, Agusan del Norte** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **four (4) persons** temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. San Isidro, Las Nieves, Agusan del Norte** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱26,392.75** worth of assistance was provided to the affected family; of which, **₱11,392.75** from **DSWD** and **₱15,000.00** from the **Local Government Unit (LGU)** (see Annex D).
