I. Situation Overview

On 14 March 2025 at around 5:20 PM, a fire incident occurred in Brgy.Tan-Awan, Kabankalan City, Negros Occidental.

II. Status of Affected Areas and Population

One (1) family or five (5) persons were affected in Brgy. Tan-Awan, City of kabanalan, Negros Occidental (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **five (5) persons** temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Tan-Awan, City of Kabankalan, Negros Occidental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱7,598.00 worth of assistance was provided to the affected family; of which, ₱6,198.00 from DSWD and ₱1,400.00 from the Local Government Unit (LGU) (see Annex D).
