

DSWD DROMIC Report on the Fire Incident in Brgy. Tobor, Malasiqui, Pangasinan

31 March 2025, 6AM

I. Situation Overview

On 14 March 2025, at approximately 1:00 PM, a residential house was destroyed by fire in Purok Boquig, Barangay Tobor, Malasiqui, Pangasinan. The house was declared totally damaged, with no personal belongings salvaged. The affected family is currently residing in a tent borrowed from the Barangay, located near the site of the burned house. As reported, the cause of the fire has been attributed to faulty electrical wiring.

In response to the incident, the Department of Social Welfare and Development (DSWD), through its Field Office in Region I, in coordination with the Local Government Unit (LGU) of Malasiqui extended financial and relief assistance consisting of Food and Non-Food Items (FNFIs) to address the immediate needs of the affected family.

Moreover, the LGU of Malasiqui assumes the management of the Internally Displaced Persons (IDPs) and is committed to continuously providing necessary interventions. Hence, the termination of this report.

II. Status of Affected Areas and Population

One (1) family or **six (6) persons** were affected in **Brgy. Tobor, Malasiqui, Pangasinan** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **six (6) persons** temporarily residing in a tent near the site of the burned house (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Tobor, Malasiqui, Pangasinan** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱31,007.72 worth of assistance was provided to the affected family composed of ₱21,770.72 from DSWD, and ₱9,237.00 from Local Government Unit (LGU) (see Annex D).
