I. Situation Overview

On 22 February 2025 at around 10:30 PM, a fire incident occurred in Brgy. Tuburan, Pototan, Iloilo. The fire was declared out at around 11:30 PM.

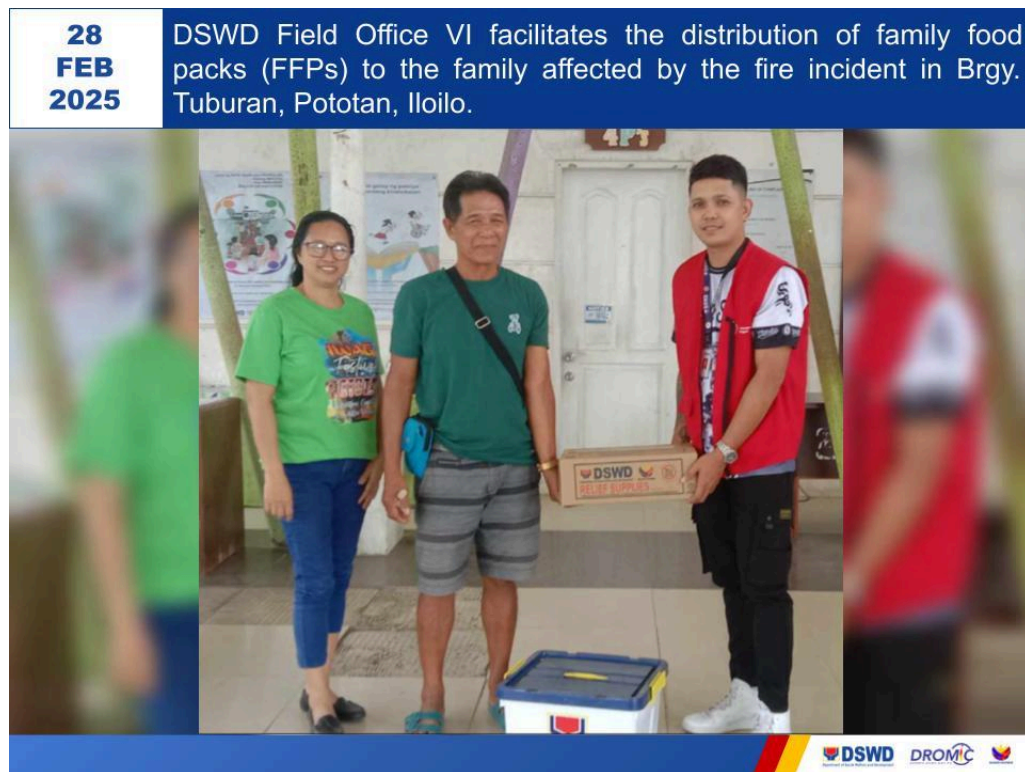
