06 March 2025, 6AM

I. Situation Overview

On 26 February 2025 at around 2:00 PM, heavy rains with strong winds caused by Easterlies were experienced in Brgy. Liberato, Laua-an, Antique. The said incident resulted in damages to the house of the affected family.
