

DSWD DROMIC Report on the Strong Wind Incident in Brgy. Lindero, Laua-an, Antique

05 March 2025, 6PM

I. Situation Overview

On 25 February 2025 at around 9:30 AM, a strong wind incident occurred in Brgy. Lindero, Laua-an, Antique. The said incident resulted in damages to the house of the affected family.

In response, the Department of Social Welfare and Development (DSWD) through its Field Office (FO) VI, provided relief assistance to support the immediate needs of the affected family.
