

DSWD DROMIC Report on the Strong Wind Incident in Brgy. Potrido, Miagao, Iloilo

04 March 2025, 6PM

I. Situation Overview

On 25 February 2025 at around 6:20 PM, a heavy rain with strong winds occurred in Brgy. Potrido, Miagao, Iloilo. The incident resulted in damages to the house of the affected family.

In response, the Department of Social Welfare and Development (DSWD) through its Field Office (FO) VI, provided them relief assistance to support their immediate needs.

One (1) family or two (2) persons temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Potrido, Miagao, Iloilo** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱4,175.44** worth of assistance was provided by the **DSWD** to the affected family (see Annex D).
