

DSWD DROMIC Report on the Strong Wind Incident in Brgy. Tumcom Ilaud, Pototan, Iloilo

19 March 2025, 6PM

I. Situation Overview

On 07 March 2025 at around 09:15 AM, heavy rains with strong winds caused by Easterlies were experienced at Sitio Maravilla, Brgy Tumcom Ilaud, Pototan, Iloilo. The said incident caused damage to one house due to a fallen tree.

The displaced family temporarily sought shelter with relatives and returned safely to their partially damaged house upon receiving clearance from the authorities.

In response to the incident, the Department of Social Welfare and Development (DSWD), through its Field Office in Region VI, provided relief assistance, including both food and non-food items, to support the immediate needs of the affected family.

II. Status of Affected Areas and Population

One (1) family or eight (8) persons were affected in Brgy. Tumcom Ilaud, Pototan, Iloilo (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or 8 persons temporarily stayed with their relatives in Brgy. Tumcod Ilaud, Pototan, Iloilo (see Annex B).

IV. Damaged Houses

One (1) house was partially damaged in Brgy. Tumcod Ilaud, Pototan, Iloilo (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱1,244.00 worth of assistance was provided by **DSWD** to the affected family (see Annex D).
