

# **DSWD DROMIC Terminal Report on the Fire Incident in Brgy. 602, Sta. Mesa, Manila City**

03 July 2025, 6AM

## **I. Situation Overview**

On 12 March 2025 at around 10:48 AM, a fire incident occurred at V. Mapa Extension corner Pat Antonio St., Brgy. 602, Sta. Mesa, Manila City. The fire was declared out at around 2:40 PM. As of 06 May 2025, the affected families have returned to their original residences.

In response to the incident, the Department of Social Welfare and Development (DSWD), through its Field Office National Capital Region (FO NCR), in close coordination with the Local Government Unit (LGU) of Manila City, provided relief assistance to support the immediate needs of the affected families and individuals.

A total of **224 families** or **747 persons** were affected in **Brgy. 602, Sta. Mesa, Manila City** (see Annex A).

A total of **224 families** or **747 persons** sought temporary shelter at the **Brgy. 602 Hall** in **Sta. Mesa, Manila City** (see Annex B).

## **IV. Damaged Houses**

A total of **40 houses** were **totally damaged** in **Brgy. 602, Sta. Mesa, Manila City** (see Annex C).

## **V. Cost of Humanitarian Assistance Provided**

A total of **₱845,824.00** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
