

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. BGH, Baguio City

21 March 2025, 6AM

I. Situation Overview

On 29 January 2025 at around 1:29 PM, a fire incident occurred in Brgy. BGH Compound, Baguio City. The fire was declared out at around 2:29 PM.

II. Status of Affected Areas and Population

A total of **seven (7) families** or **27 persons** were affected in **Brgy. BGH Compound, Baguio City** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **seven (7) families** or **27 persons** are temporarily staying with their relatives after seeking temporary shelter at the City Disaster Risk Reduction Management Office (**CDRRMO**) in **Jose Felipe St., CEO Compound, Lower Rock Quarry, Baguio City** (see Annex B).

IV. Damaged Houses

A total of **two (2) houses** were **totally damaged** in **Brgy. BGH Compound, Baguio City** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱543,823.36 worth of assistance was provided to the affected families; of which, ₱141,473.36 from DSWD, ₱73,100.00 from the Local Government Unit (LGU), ₱320,000.00 from Non-Government Organizations (NGOs), and ₱9,250.00 from other Partners (see Annex D).
