

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Balabag, Malay, Aklan 18 April 2025, 6PM

I. Situation Overview

On 03 March 2025 at around 10:30 PM, a fire incident occurred in Brgy. Balabag, Malay, Aklan. The Bureau of Fire Protection (BFP) promptly responded to extinguish the fire, which was declared out at around 1:30 AM on 04 March 2025.

II. Status of Affected Areas and Population

A total of **14 families** or **34 persons** were affected in **Brgy. Balabag, Malay, Aklan** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **14 families** or **34 persons** temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

A total of **four (4) houses** were damaged; of which, **three (3)** are **totally damaged** and **one (1)** is **partially damaged** in **Brgy. Balabag, Malay, Aklan** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱140,688.00** worth of assistance was provided to the affected families; of which, **₱33,528.00** from **DSWD** and **₱107,160.00** from the **Local Government Unit (LGU)** (see Annex D).
