

# DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Buntatala, Jaro, Iloilo City

21 May 2025, 6PM

### I. Situation Overview

On 16 February 2025 at around 2PM, a fire broke out at Zone 7 Relocation Site, Brgy. Buntatala, Jaro, Iloilo City. The Bureau of Fire Protection (BFP) promptly responded to the scene and extinguished the fire by 2:58 PM. Several residential structures were destroyed, displacing numerous residents in the area.

# II. Status of Affected Areas and Population

A total of **29 families** or **95 persons** were affected in **Brgy. Buntatala, Jaro, Iloilo City** (see Annex A).

## III. Status of Displaced Population

#### a. Inside Evacuation Center

A total of **16 families** or **73 persons** sought temporary shelter at the **covered court** in **Brgy. Buntatala, Jaro, Iloilo City** (see Annex B).

#### b. Outside Evacuation Center

A total of **13 families** or **22 persons** temporarily stayed with their relatives (see Annex C).

### c. Total Displaced Population

A total of **29 families** or **95 persons** were displaced in **Brgy. Buntatala, Jaro, lloilo City** (see Annex D).

# IV. Damaged Houses

A total of **12 houses** were damaged; of which, **nine (9)** are **totally damaged** and **three (3)** are **partially damaged** in **Brgy. Buntatala, Jaro, Iloilo City** (see Annex E).

#### V. Cost of Humanitarian Assistance Provided

A total of **₱307,644.80** worth of assistance was provided to the affected families; of which, **₱215,330.00** from **DSWD** and **₱92,314.80** from the **Local Government Unit (LGU)** (see Annex F).
