

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Crossing Bayabas, Davao City

01 April 2025, 6AM

I. Situation Overview

On 11 January 2025 at around 3:05 PM, a fire incident occurred at Purok 12-Saint Matthew corner Saint Paul Crossing, Brgy. Crossing Bayabas, Toril, Davao City. The fire was declared out at around 4:41 PM. Due to the incident, 93 individuals were affected resulting in significant damages to their houses.

In response, the Department of Social Welfare and Development (DSWD) through its Field Office (FO) XI, in coordination with the Local Government Unit (LGU) of Davao City, promptly provided relief assistance to support the immediate needs of the affected families and individuals.

A total of **27 families** or **93 persons** sought temporary shelter at the **Brgy. Crossing Bayabas Evacuation Center in Davao City** (see Annex B).

IV. Damaged Houses

A total of **27 houses** were **totally damaged** in **Brgy. Crossing Bayabas, Davao City** (see Annex D).

V. Cost of Humanitarian Assistance Provided

A total of **₱244,377.00** worth of assistance was provided by **DSWD** to the affected families (see Annex E).
