

# DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Lubogan, Davao City

19 May 2025, 6AM

# I. Situation Overview

On 05 March 2025 at around 4:44 PM, a fire incident occurred at Purok 16, Carson St., Brgy. Lubogan, Davao City. The fire was declared out at around 6:50 PM. Due to the incident, 263 individuals were affected and caused significant damage to their houses.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office (FO) XI, together with the Local Government Unit (LGU) of Davao City, immediately provided food and non-food items (FNIs) and financial assistance (FA) to address the urgent needs of the affected individuals.

# II. Status of Affected Areas and Population

A total of **122 families** or **263 persons** were affected in **Brgy. Lubogan, Davao City** (see Annex A).

# III. Status of Displaced Population

a. Inside Evacuation Center

A total of **122 families** or **263 persons** sought temporary shelter at the **UDHA Gymnasium Evacuation Center** in **Brgy. Lubogan, Davao City** (see Annex B).

# IV. Damaged Houses

A total of **119 houses** were damaged; of which, **117** are **totally damaged** and **two** (2) are partially damaged in Brgy. Lubogan, Davao City (see Annex E).

# V. Cost of Humanitarian Assistance Provided

A total of **₱3,205,634.00** worth of assistance was provided to the affected families; of which, **₱975,634.00** from **DSWD** and **₱2,230,000.00** from the **LGU** (see Annex F).
