

## DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Napolan, Pagadian City, Zamboanga del Sur

11 May 2025, 6AM

### I. Situation Overview

On 27 March 2025 at around 10:12 AM, a fire incident occurred at Purok San Francisco, Phase 2, Brgy. Napolan, Pagadian City, Zamboanga del Sur. The fire was declared out at around 10:40 AM. Due to the incident, 15 individuals were affected and caused significant damage to their houses.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office (FO) IX, in coordination with the Local Government Unit (LGU) of Pagadian City, Zamboanga del Sur, immediately provided relief assistance to address the urgent needs of the affected individuals.

A total of **five (5) families** or **15 persons** were affected in **Brgy. Napolan, Pagadian City, Zamboanga del Sur** (see Annex A).

### III. Status of Displaced Population

#### Outside Evacuation Center

A total of **five (5) families** or **15 persons** temporarily stayed with their relatives or friends (see Annex B).

### IV. Damaged Houses

A total of **two (2) houses** were damaged; of which, **one (1)** is **totally damaged** and **one (1)** is **partially damaged** in **Brgy. Napolan, Pagadian City, Zamboanga del Sur** (see Annex C).

### V. Cost of Humanitarian Assistance Provided

A total of **₱3,575.00** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
