

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. Obong, Basista, Pangasinan

24 May 2025, 6PM

I. Situation Overview

On 28 February 2025 at around 8:50 AM, a fire incident occurred in Brgy. Obong, Basista, Pangasinan. Due to the incident, three (3) individuals were affected and caused total damage to their house.

In response, the Department of Social Welfare and Development (DSWD) through its Field Office (FO) I, together with the Local Government Unit (LGU) of Basista, Pangasinan, immediately provided food and non-food items (FNIs) and financial assistance (FA) to the affected individuals.

II. Status of Affected Areas and Population

One (1) family or three (3) persons were affected in **Brgy. Obong, Basista, Pangasinan** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or three (3) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Obong, Basista, Pangasinan** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱31,078.36** worth of assistance was provided to the affected family; of which, **₱21,078.36** from **DSWD** and **₱10,000.00** from the **LGU** (see Annex D).
