

DSWD DROMIC Terminal Report on the Fire Incident in Brgy. San Miguel, Pasig City

20 March 2025, 6PM

I. Situation Overview

On 09 January 2025 at around 9:26 AM, a fire incident occurred at Brgy. San Miguel, Pasig City. The fire was declared out at around 9:51 AM. Due to the incident, 187 individuals were affected resulting in total damages of 26 houses.

In response to the incident, the Department of Social Welfare and Development (DSWD), through its Field Office National Capital Region (FO NCR), in close coordination with the Local Government Unit (LGU) of Pasig City, provided relief assistance to support the immediate needs of the affected families and individuals.

II. Status of Affected Areas and Population

A total of **48 families or 187 persons** were affected in **Brgy. San Miguel, Pasig City** (see Annex A).

III. Status of Displaced Population

Inside Evacuation Center

A total **48 families or 187 persons** sought temporary shelter at the **Tambakan 2 Municipal Hall** in **Pasig City** (see Annex B).

IV. Damaged Houses

A total of **26 houses** were **totally damaged** in **Brgy. San Miguel, Pasig City** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱107,361.18** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
