

DSWD DROMIC Report #1 on the Fire Incident in Brgy. Baretbet, Bagabag, Nueva Vizcaya as of 03 April 2025, 6AM

I. Situation Overview

On 30 March 2025 at around 3:00 AM, a fire incident occurred in Brgy. Baretbet, Bagabag, Nueva Vizcaya.

In response, the Department of Social Welfare and Development (DSWD) through its Field Office (FO) II in close coordination with the Local Government Unit (LGU) of Bagabag, Nueva Vizcaya, immediately provided food and non-food items (FNIs) to the affected family to support their immediate needs.

II. Status of Affected Areas and Population

One (1) family or **five (5) persons** are affected in **Brgy. Baretbet, Bagabag, Nueva Vizcaya** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **five (5) persons** temporarily staying with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Baretbet, Bagabag, Nueva Vizcaya** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱14,667.35** worth of assistance was provided to the affected family; of which, **₱9,667.35** from **DSWD** and **₱5,000.00** from the **Local Government Unit (LGU)** (see Annex D).

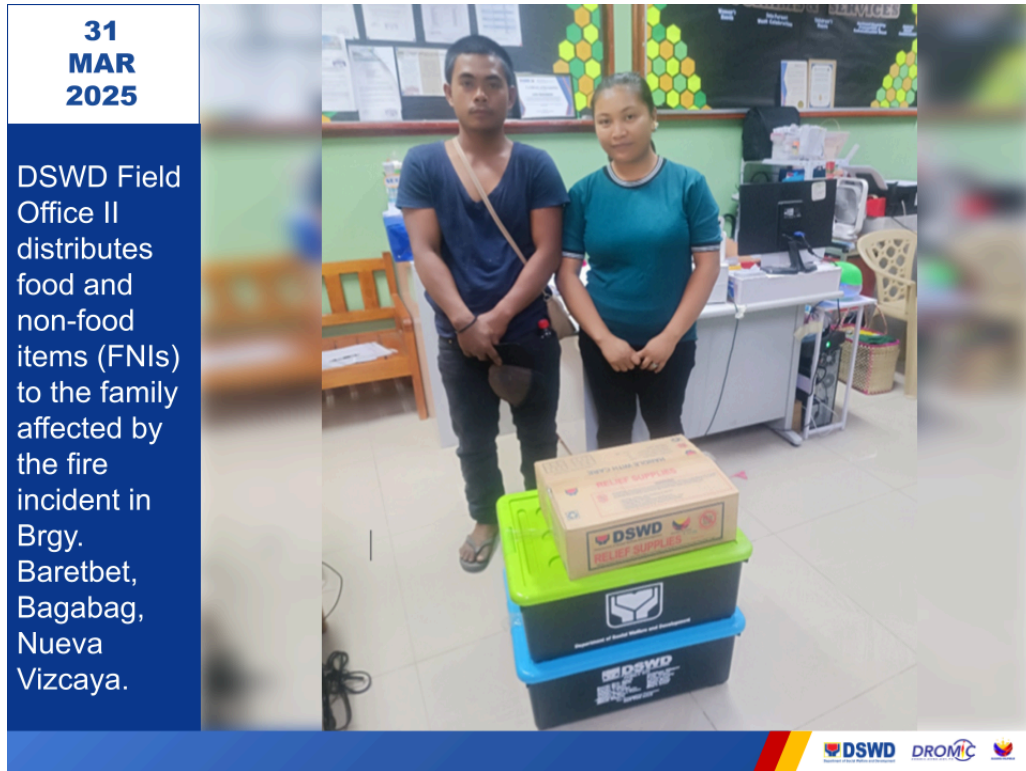
