

# DSWD DROMIC Report #1 on the Fire Incident in Brgy. Canelar, Zamboanga City

as of 16 April 2025, 6AM

## I. Situation Overview

On 15 April 2025 at around 4:20 PM, a fire incident occurred at Lemon Drive, Brgy. Canelar, Zamboanga City. The fire was declared out at around 6:30 PM. Due to the incident, 70 individuals were affected, significantly damaging their houses.

In response, the Department of Social Welfare and Development (DSWD) through its Field Office (FO) IX, in close coordination with the Local Government Unit (LGU) of Zamboanga City, provided initial relief assistance to address the urgent needs of the affected individuals.

A total of **20 families** or **70 persons** are affected in **Brgy. Canelar, Zamboanga City** (see Annex A).

# III. Status of Displaced Population

## **Inside Evacuation Center**

There are 20 families or 70 persons currently taking temporary shelter at the Canelar Covered Court in Brgy. Canelar, Zamboanga City (see Annex B).

# IV. Damaged Houses

A total of eight (8) houses were damaged; of which, seven (7) are totally damaged and one (1) is partially damaged in Brgy. Canelar, Zamboanga City (see Annex C).

#### V. Cost of Humanitarian Assistance Provided

A total of **P4,390.00** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
