

DSWD DROMIC Report #1 on the Fire Incident in Brgy. Carmen West, Rosales, Pangasinan

24 April 2025, 6PM

I. Situation Overview

On 01 April 2025 at around 7:00 AM, a fire incident occurred in Brgy. Carmen West, Rosales, Pangasinan. Due to the incident, nine (9) individuals were affected, significantly damaging their house.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office (FO) I, closely coordinated with the Local Government Unit (LGU) of Rosales, Pangasinan, to facilitate the immediate distribution of the relief assistance to address the urgent needs of the affected individuals. This is part of the relief augmentation support to the assistance provided by the LGU of Rosales, Pangasinan.

II. Status of Affected Areas and Population

A total of **four (4) families** or **nine (9) persons** are affected in **Brgy. Carmen West, Rosales, Pangasinan** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

There are **four (4) families** or **nine (9) persons** temporarily staying with their relatives or friends (see Annex B).

IV. Damaged Houses

A total of **four (4) houses** were **totally damaged** in **Brgy. Carmen West, Rosales, Pangasinan** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱40,000.00** worth of assistance was provided by the **LGU** to the affected families (see Annex D).
