

DSWD DROMIC Report #1 on the Fire Incident in Brgy. San Quintin, Alfonso Lista, Ifugao

as of 29 April 2025, 6PM

I. Situation Overview

On 30 March 2025 at around 1:28 PM, a fire incident occurred at Brgy. San Quintin, Alfonso Lista, Ifugao. A concerned neighbor reported the incident to the Bureau of Fire Protection (BFP); however, the house had already been gutted by the time responders arrived. The fire fully extinguished at around 3 PM. The family residing in the house was not present during the incident. They have since sought temporary shelter with nearby relatives while working to gather resources for the reconstruction of their home.

II. Status of Affected Areas and Population

One (1) family or **four (4) persons** are affected in **Brgy. San Quintin, Alfonso Lista, Ifugao** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or **four (4) persons** are temporarily staying with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. San Quintin, Alfonso Lista, Ifugao** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱29,467.05** worth of assistance was provided to the affected family; of which, **₱9,467.05** from **DSWD** and **₱20,000.00** from the **Local Government Unit (LGU)** (see Annex D).
