I. Situation Overview

On 23 April 2025 at around 4:00 AM, a fire incident occurred in Brgy. Tambulilid, Ormoc City, Leyte.

A total of **six (6) families** or **14 persons** are affected in **Brgy. Tambulilid, Ormoc City, Leyte** (see Annex A).

III. Status of Displaced Population

Inside Evacuation Center

There are **six (6) families** or **14 persons** currently taking temporary shelter at the **Covered Court** in **Brgy. Tambulilid, Ormoc City, Leyte** (see Annex B).

IV. Damaged Houses

A total of **six (6) houses** were damaged, of which, **five (5)** are **totally damaged** and **one (1)** is **partially damaged** in **Brgy. Tambulilid, Ormoc City, Leyte** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱60,000.00** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
