

DSWD DROMIC Report #2 on the Fire Incident in Brgy. Sucodan, Kolambugan, Lanao del Norte

as of 15 April 2025, 6AM

I. Situation Overview

On 14 March 2025 at around 2:18 PM, a fire incident occurred in Brgy. Sucodan, Kolambugan, Lanao del Norte. The fire was declared out at around 2:40 PM. Due to the incident, nine (9) individuals were affected resulting in significant damages to their houses.

In response, the Department of Social Welfare and Development (DSWD) through its Field Office (FO) X, together with the Local Government Unit (LGU) of Kolambugan, Lanao del Norte, immediately provided assistance to the affected individuals to support their immediate needs.

II. Status of Affected Areas and Population

A total of **four (4) families** or **nine (9) persons** are affected in **Brgy. Sucodan, Kolambugan, Lanao del Norte** (see Annex A).

III. Status of Displaced Population

Inside Evacuation Center

There are **four (4) families** or **nine (9) persons** currently taking temporary shelter at **the Brgy. Sucodan Hall in Kolambugan, Lanao del Norte** (see Annex B).

IV. Damaged Houses

A total of **two (2) houses** were **totally damaged** in **Brgy. Sucodan, Kolambugan, Lanao del Norte** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱37,788.00** worth of assistance was provided to the affected families; of which, **₱34,288.00** from **DSWD**, and **₱3,500.00** from the **LGU** (see Annex D).
