

# DSWD DROMIC Report on the Armed Conflict in Brgy. Libertad, Cawayan, Masbate

30 April 2025, 6PM

# I. Situation Overview

On 17 April 2025 at around 5:45 AM, an armed conflict transpired in Brgy. Libertad, Cawayan, Masbate between the 9th Infantry "Spear" Division of the Philippine Army and members of the New People's Army (NPA). The firefight lasted approximately 15 minutes, prompting several families to flee and seek temporary shelter with neighbors within the barangay.

A total of **nine (9) families** or **36 persons** were affected in **Brgy. Libertad**, **Cawayan**, **Masbate** (see Annex A).
