

DSWD DROMIC Report on the Fire Incident in Brgy. Allangigan, Conner, Apayao

08 April 2025, 6PM

I. Situation Overview

On 04 December 2024 at around 4:30 AM, a fire incident occurred at Purok 4, Brgy. Allangigan, Conner, Apayao. Due to the incident, three (3) individuals were affected resulting in significant damages to their house.

In response, the Department of Social Welfare and Development (DSWD), through its Field Office (FO) Cordillera Administrative Region (CAR), together with the Local Government Unit (LGU) of Conner, Apayao, promptly provided assistance to support the immediate needs of the affected individuals.

II. Status of Affected Areas and Population

One (1) family or three (3) persons were affected in Brgy. Allangigan, Conner, Apayao (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or three (3) persons temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Allangigan, Conner, Apayao** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱58,381.70 worth of assistance was provided to the affected families; of which, ₱18,381.70 from DSWD and ₱40,000.00 from the LGU (see Annex D).
