**One (1) house** was **totally damaged** in **Brgy. Aparicio, Ibajay, Aklan** (see Annex C).

### V. Cost of Humanitarian Assistance Provided

A total of **₱26,698.00** worth of assistance was provided to the affected family; of which, **₱6,198.00** from **DSWD** and **₱20,500.00** from the **Local Government Unit (LGU)** (see Annex D).
