

DSWD DROMIC Report on the Fire Incident in Brgy. Aurora, Tagana-an, Surigao del Norte

29 April 2025, 6PM

I. Situation Overview

On 20 April 2025 at around 8 PM, a fire incident occurred in Brgy. Aurora, Tagana-an, Surigao del Norte. The Bureau of Fire Protection (BFP) responded and extinguished the fire at around 9 PM. The fire partially gutted a house, resulting in the displacement of a family who immediately sought temporary shelter with their relatives. No injuries or casualties were reported during the incident.

II. Status of Affected Areas and Population

One (1) family or five (5) persons were affected in **Brgy. Aurora, Tagana-an, Surigao del Norte** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or five (5) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **partially damaged** in **Brgy. Aurora, Tagana-an, Surigao del Norte** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱15,681.50** worth of assistance was provided to the affected family; of which, **₱10,681.50** from **DSWD** and **₱5,000.00** from the **Local Government Unit (LGU)** (see Annex D).
