

# DSWD DROMIC Report on the Fire Incident in Brgy. Aurora, Tagana-an, Surigao del Norte

29 April 2025, 6PM

## I. Situation Overview

On 20 April 2025 at around 8 PM, a fire incident occurred in Brgy. Aurora, Tagana-an, Surigao del Norte. The Bureau of Fire Protection (BFP) responded and extinguished the fire at around 9 PM. The fire partially gutted a house, resulting in the displacement of a family who immediately sought temporary shelter with their relatives. No injuries or casualties were reported during the incident.

# II. Status of Affected Areas and Population

One (1) family or five (5) persons were affected in Brgy. Aurora, Tagana-an, Surigao del Norte (see Annex A).

#### III. Status of Displaced Population

Outside Evacuation Center One (1) family or five (5) persons temporarily stayed with their relatives (see Annex B).

## IV. Damaged Houses

**One (1) house** was **partially damaged** in **Brgy. Aurora, Tagana-an, Surigao del Norte** (see Annex C).

#### V. Cost of Humanitarian Assistance Provided

A total of ₱15,681.50 worth of assistance was provided to the affected family; of which, ₱10,681.50 from DSWD and ₱5,000.00 from the Local Government Unit (LGU) (see Annex D).
