

DSWD DROMIC Report on the Fire Incident in Brgy. Aawayan, Aguinaldo, Ifugao

29 April 2025, 6PM

I. Situation Overview

On 15 April 2025 at around 2:30 PM, a fire incident occurred in Brgy. Aawayan, Aguinaldo, Ifugao. The fire was declared out at around 3:45 PM. It resulted in the destruction of a residential structure. The affected family temporarily took shelter in their store located in a nearby barangay.

One (1) family or three (3) persons were affected in **Brgy. Aawayan, Aguinaldo, Ifugao** (see Annex A).
