

DSWD DROMIC Report on the Fire Incident in Brgy. Awayan, Aguinaldo, Ifugao

29 April 2025, 6PM

I. Situation Overview

On 15 April 2025 at around 2:30 PM, a fire incident occurred in Brgy. Awayan, Aguinaldo, Ifugao. The fire was declared out at around 3:45 PM. It resulted in the destruction of a residential structure. The affected family temporarily took shelter in their store located in a nearby barangay.

One (1) family or three (3) persons were affected in Brgy. Awayan, Aguinaldo, Ifugao (see Annex A).

One (1) house was totally damaged in Brgy. Awayan, Aguinaldo, Ifugao (see Annex B).

IV. Cost of Humanitarian Assistance Provided

A total of ₱8,674.20 worth of assistance was provided by **DSWD** to the affected family (see Annex C).
