I. Situation Overview

On 08 April 2025 at around 9:30 AM, a fire incident occurred in Brgy. Buenavista Rizal, Pontevedra, Negros Occidental.

One (1) family or **four (4) persons** temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy, Buenavista Rizal, Pontevedra, Negros Occidental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱6,500.00** worth of assistance was provided by **DSWD** to the affected family (see Annex D).
