

DSWD DROMIC Report on the Fire Incident in Brgy. Cabayawa, Tubay, Agusan del Norte

28 April 2025, 6PM

I. Situation Overview

On 31 March 2025 at around 3:00 PM, a fire incident occurred at Purok 7, Brgy. Cabayawa, Tubay, Agusan del Norte. The fire was declared out at around 4:00 PM.

II. Status of Affected Areas and Population

One (1) family or two (2) persons were affected in **Brgy. Cabayawa, Tubay, Agusan del Norte** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or two (2) persons temporarily stayed with their relatives or friends (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Cabayawa, Tubay, Agusan del Norte** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱16,358.50** worth of assistance was provided to the affected families; of which, **₱11,358.50** from **DSWD** and **₱5,000.00** from the **Local Government Unit (LGU)** (see Annex D).
