I. Situation Overview

On 14 April 2025 at around 7:00 PM, a fire incident occurred in Brgy. Cabugcabug, President Roxas, Capiz. The fire was declared out at around 8:00 PM.

One (1) house was **totally damaged** in **Brgy. Cabugcabug, President Roxas, Capiz** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱7,368.00** worth of assistance was provided by **DSWD** to the affected family (see Annex D).
