

DSWD DROMIC Report on the Fire Incident in Brgy. Camp 3, Tuba, Benguet

29 April 2025, 6PM

I. Situation Overview

On 03 March 2025 at around 1:40 PM, a fire incident occurred at Upper Camp, Philex, Brgy. Camp 3, Tuba, Benguet. Residential structures were completely destroyed, resulting in the displacement of several families. The fire was declared out at around 3 PM.

II. Status of Affected Areas and Population

A total of **18 families** or **42 persons** were affected in **Brgy. Camp 3, Tuba, Benguet** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **14 families** or **37 persons** temporarily stayed with their neighbors or nearby relatives. (see Annex B).

IV. Damaged Houses

A total of **nine (9) houses** were **totally damaged** in **Brgy. Camp 3, Tuba, Benguet** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of ₱539,457.70 worth of assistance was provided to the affected families; of which, ₱289,457.70 from DSWD and ₱250,000.00 from the Local Government Unit (LGU) (see Annex D).
