

## DSWD DROMIC Report on the Fire Incident in Brgy. Gaub, Cabatuan, Iloilo 23 April 2025, 6AM

### I. Situation Overview

On 18 April 2025 at around 5:18 PM, a fire incident occurred in Brgy. Gaub, Cabatuan, Iloilo. The fire was declared out at around 6:00 PM.
