I. Situation Overview

On 18 April 2025 at around 9:05 PM, a fire incident occurred in Brgy. Imbang Pequeño, San Enrique, Iloilo. The fire was declared out at around 10:00 PM.

V. Cost of Humanitarian Assistance Provided

A total of **₱13,664.00** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
