

## **DSWD DROMIC Report on the Fire Incident in Brgy. Inayawan, Cauayan, Negros Occidental**

30 April 2025, 6AM

### **I. Situation Overview**

On 05 April 2025 at around 8:30 PM, a fire incident occurred in Brgy. Inayawan, Cauayan, Negros Occidental. Due to the incident, four (4) individuals were affected resulting in significant damages to their house.

In response, the Department of Social Welfare and Development (DSWD) through its Field Office (FO) VI, together with the Local Government Unit (LGU) of Cauayan, Negros Occidental, provided Food and Non-Food Items (FNIs) to the affected individuals.

**One (1) family or four (4) persons** were affected in **Brgy. Inayawan, Cauayan, Negros Occidental** (see Annex A).

### **III. Status of Displaced Population**

#### **Outside Evacuation Center**

**One (1) family or four (4) persons** temporarily stayed with their relatives or friends (see Annex B).

### **IV. Damaged Houses**

**One (1) house** was **totally damaged** in **Brgy. Inayawan, Cauayan, Negros Occidental** (see Annex C).

### **V. Cost of Humanitarian Assistance Provided**

A total of **₱8,938.00** worth of assistance was provided to the affected family; of which, **₱5,938.00** from **DSWD** and **₱3,000.00** from the **LGU** (see Annex D).
