

# DSWD DROMIC Report on the Fire Incident in Brgy. Jaguimitan, City of Passi, Iloilo

03 April 2025, 6AM

## I. Situation Overview

On 24 March 2025 at around 9:29 AM, a fire incident occurred in Brgy. Jaguimitan, City of Passi, Iloilo. The fire was declared out at around 10:00 AM.

In response, the Department of Social Welfare and Development (DSWD) through its Field Office (FO) VI, in close coordination with the Local Government Unit (LGU) of City of Passi, immediately provided food and non-food items (FNIs) to the affected family to support their immediate needs.
