

DSWD DROMIC Report on the Fire Incident in Brgy. Laga-an, Calatrava, Negros Occidental

12 April 2025, 6AM

I. Situation Overview

On 03 April 2025 at around 2:00 PM, a fire incident occurred in Brgy. Laga-an, Calatrava, Negros Occidental.

In response to the incident, the Department of Social Welfare and Development (DSWD), through its Field Office in Region VI, provided relief assistance to support the immediate needs of the affected family.
