

DSWD DROMIC Report on the Fire Incident in Brgy. Lantangan, Carles, Iloilo

16 April 2025, 6AM

I. Situation Overview

On 02 April 2025 at around 1:00 PM, a fire incident occurred in Brgy. Lantangan, Carles, Iloilo. The fire was declared out at around 1:30 PM. Due to the incident, 10 individuals were affected, significantly damaging their houses.

In response, the Department of Social Welfare and Development (DSWD) through its Field Office (FO) VI, in coordination with Local Government Unit (LGU) of Carles, Iloilo, promptly provided relief assistance to support the immediate needs of the affected individuals.

A total of **two (2) families** or **10 persons** were affected in **Brgy. Lantangan, Carles, Iloilo** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

A total of **two (2) families or 10 persons** temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

A total of **two (2) houses** were damaged; of which, **one (1)** is **totally damaged** and **one (1) is partially damaged** in **Brgy. Lantangan, Carles, Iloilo** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱4,272.00** worth of assistance was provided by **DSWD** to the affected families (see Annex D).
