

DSWD DROMIC Report on the Fire Incident in Brgy. Limalima, Isabela, Negros Occidental

30 April 2025, 6PM

I. Situation Overview

On 07 April 2025 at around 7 PM, a fire incident occurred in Sitio Mandapipi, Brgy. Limalima, Isabela, Negros Occidental. The fire completely destroyed a residential structure, resulting in the displacement of one (1) family. The affected family sought temporary shelter with relatives.

II. Status of Affected Areas and Population

One (1) family or eight (8) persons were affected in **Brgy. Limalima, Isabela, Negros Occidental** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or eight (8) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Limalima, Isabela, Negros Occidental** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱17,496.00** worth of assistance was provided to the affected family; of which, **₱7,496.00** from **DSWD** and **₱10,000.00** from the **Local Government Unit (LGU)** (see Annex D).
