

DSWD DROMIC Report on the Fire Incident in Brgy. Lualhati, Baguio City

06 April 2025, 6PM

I. Situation Overview

On 05 August 2024, at around 2:00 PM, a fire incident occurred at Purok 2, Brgy. Lualhati, Baguio City. The fire was declared out at around 3:02 PM. Due to the incident, three (3) individuals were affected, significantly damaging their house.

In response, the Department of Social Welfare and Development (DSWD) through its Field Office (FO) Cordillera Administrative Region (CAR), together with the Local Government Unit (LGU) of Baguio City, promptly provided relief assistance to support the immediate needs of the affected individuals.

One (1) family or three (3) persons were affected in Brgy. Lualhati, Baguio City (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or three (3) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was totally damaged in Brgy. Lualhati, Baguio City (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱19,558.00** worth of assistance was provided to the affected family; of which, **₱7,058.00** from **DSWD** and **₱12,500.00** from the **LGU** (see Annex D).
