

DSWD DROMIC Report on the Fire Incident in Brgy. Magnuang, City of Batac, Ilocos Norte 14 April 2025, 6AM

I. Situation Overview

On 26 March 2025 at around 11:45 AM, a fire incident occurred in Brgy. Magnuang, City of Batac, Ilocos Norte. Due to the incident, four (4) individuals were affected resulting in significant damage to their house.

In response, the Department of Social Welfare and Development (DSWD) through its Field Office (FO) I, in close coordination with the Local Government Unit (LGU) of City of Batac, Ilocos Norte, immediately provided food and non-food items (FNIs) and financial assistance to the affected individuals to support their immediate needs.

II. Status of Affected Areas and Population

One (1) family or four (4) persons were affected in **Brgy. Magnuang, City of Batac, Ilocos Norte** (see Annex A).

III. Status of Displaced Population

Outside Evacuation Center

One (1) family or four (4) persons temporarily stayed with their relatives (see Annex B).

IV. Damaged Houses

One (1) house was **totally damaged** in **Brgy. Magnuang, City of Batac, Ilocos Norte** (see Annex C).

V. Cost of Humanitarian Assistance Provided

A total of **₱19,134.00** worth of assistance was provided to the affected families; of which, **₱17,634.00** from **DSWD** and **₱1,500.00** from the **LGU** (see Annex D).
